SUBJECT: 2021-22 Permit Updates and Trainings

Required Action:

- Update list of individuals responsible for permit processing by October 16.
- Direct individuals responsible for permit processing to upcoming training opportunities via Canvas and video conference.

It is time to begin preparation for the out-of-boundary permit application season. As a reminder, the open enrollment window runs from December 1 to the third Friday in February (February 19, 2021). Permits will again be accepted and processed through PowerSchool.

Update Information

This year, each school will need to update the list of authorized users for their location. The building principal, by default, will have access to the system. Schools will need to identify other administrators who will need access and any staff members who will be involved in processing. This information will be updated on the Google Sheet linked below and must be completed by October 16, 2020.
