## Kindergarten Entry & Exit Profile (KEEP)--BOY (K)

Testing Window: - First three weeks before school to three weeks after school begins

Classroom aides can now administer the KEEP along with licensed educators. The stipulation is that the classroom aide must be trained to administer the KEEP. Kindergarten teachers will need to register for a Data Gateway account in order to enter the KEEP test data. Any others needing to enter/view KEEP data will also need a Data Gateway account.
