## US Civics Test (Grades 11 and 12 as needed)

Testing Window: 8/29/2022 to 3/17/2023

The Civics test will be given online this year via UTIPS: <https://jordan.utips.org/>. The online test will be scored automatically. Information Systems will upload passed tests to Skyward monthly, eliminating the need for teachers to enter data. Office staff will still be able to enter or modify the data directly in the Educational Milestones module. Once data has been loaded into the Educational Milestones module it is viewable in Skyward Family Access and shows on transcripts. They are designed to be used formatively. They are a fixed-form test, not adaptive. All schools will be expected to administer the WIDA test themselves in grades 10-12. The assessment department will test students requiring alternate testing. Expect delivery of workbooks and other testing materials in December. The test will be administered to your ELL students who are at LPL levels 1, 2, 3, or 4. ## **Utah Aspire Plus (10 only)**

Testing Window: 3/6/2023 - 5/12/2023

There will be 4 component tests: English, Reading, Mathematics, and Science. Schools can choose to administer these tests ACT-style (all in one sitting with short breaks), or RISE-style (every teacher signs up for a day in the window). These tests are timed and once a test component has been started, it must be completed and submitted in one testing session.
