Spring AAPPL Testing

Testing Window: March – End of Year

DLM: Spring Summative (LA, MA, SC) (per IEP) (10-11)

Testing Window: 3/14/2022 - 6/10/2022

DLM will be used to test science this year as well as ELA and math. The DLM functions as the alternate test for 10th and 11th graders who are not eligible for the Utah Aspire Plus or ACT tests. Information will be posted on the assessment website:

Utah Aspire Plus (10 only)

Testing Window: 3/7/2022 - 5/13/2022

We encourage schools to begin UA+ testing early enough in the window to leave time for absent testing. There will be 4 component tests: English, Reading, Mathematics, and Science. Schools can choose to administer these tests ACT-style (all in one sitting with short breaks), or RISE-style (every teacher signs up for a day in the window). These tests are timed and once a test component has been started, it must be completed and submitted in one testing session.
