SAGE Benchmarks

No testing window; always available

SAGE benchmark tests allow teachers to give brief (15-30 min) online assessments for one reporting category or standard. These test are designed to be used formatively. They are fixed-form tests, not adaptive. The questions are drawn from the SAGE Interim item bank. Student scores *and* responses will both be visible in teacher reports. The scores and reports will be accessed via AIR Ways Reporting, a new reporting tool, instead of via ORS. Data for this past school year has all been loaded into the educational milestone module and is viewable in Skyward Family Access and shows on transcripts.
