Starting Jan 1, 2016, students must pass this test in order to graduate HS. The Civics test will be given via paper and pencil/scantron again this year. The results will be recorded by each teacher in Skyward EA+ within the testing module. A nightly process will copy the information from the testing module to the educational milestone module. Office staff will also be able to enter or modify the data directly in the educational milestone module. Data for this past school year has all been loaded into the educational milestone module and is viewable in Skyward Family Access and shows on transcripts.
