## SAGE Summative USTAR (10 & 12-- no grade 11)

The summer USTAR SAGE testing follows the same guidelines as end-of-year SAGE testing for 2016-2017. Any students who were in grade 11 for the 2016-2017 school year will not be tested. Any students who were in grades 7,8,9, or 10 for the 2016-2017 school year will be. If students have already opted out, teachers will be notified. New opt-outs must be recorded and will only count for the 2016-2017 school year. The Civics test will be given online this year via UTIPS: <https://jordan.utips.org/> . The online test will be scored automatically. Info Sys will upload passed tests to Skyward monthly, eliminating the need for teachers to enter data. Office staff will still be able to enter or modify the data directly in the educational milestone module. Once data has been loaded into the educational milestone module it is viewable in Skyward Family Access and shows on transcripts. ## SAGE Benchmarks (10-12)

Testing window **8/22/2017 to 6/15/2018**

SAGE benchmark tests allow teachers to give brief (15-30 min) online assessments for one reporting category or standard. These tests are designed to be used formatively. They are fixed-form tests, not adaptive. The questions are drawn from the SAGE Interim item bank. Student scores and responses are both visible in teacher reports. The scores and reports are accessed via AIR Ways Reporting instead of via ORS.
