Info Sys will upload passed tests to Skyward monthly, eliminating the need for teachers to enter data. Office staff will still be able to enter or modify the data directly in the educational milestone module. Once data has been loaded into the educational milestone module it is viewable in Skyward Family Access and shows on transcripts. SAGE Benchmarks (7-9)
