Return to Play Spectator Protocols (subject to change) Alpine, Canyons, Davis, Granite, Jordan, Salt Lake

The following information provides direction for schools in accordance with health guidelines as we resume school sponsored athletics and activities. As guidelines are adjusted by the health department and government officials, we will send out updated information. For the safety of spectators, athletes, coaches, their families, and the community at large, these guidelines must be followed.

1) Ticketed Events

- School officials will determine the capacity of their home venue seating and may sell 25% of the capacity to spectators. Athletes/Cheer/Band/School Supervision do not factor into the 25% unless they are in the bleachers. (2 tickets per athlete is recommended for parents.)
- School officials will also determine the capacity of their venue's visitor seating and will
 work with the visiting school to sell 25% of the seating capacity in the visitor section for
 visiting spectators.
- All ticket purchases must be done in advance via electronic (VNN/Go Fan/Hometown Ticketing/Etc.) touchless system or out of the main office. Same day ticketing will NOT be sold at the game/event.
- A spectator agreement form is required for spectators who must agree to before an individual can purchase tickets.

2) Non-Ticketed Events

Gymnasium, Stadium, and Auditorium use will follow the same capacity guidelines as ticketed events. The school may limit capacity by issuing electronic \$0 cost tickets or have a plan to limit capacity. All other Non-ticketed Events including Sophomore and JV games, spectators are required to wear masks while on school property.

Schools will have parents sign the Spectator Agreement Form. (This would preferably be accomplished at the required parent meeting before the season). Administration and school officials will enforce wearing masks and social distancing for students at school events and ask that the public will adhere to these guidelines.

3) Spectator Agreement Form

Spectator Agreement Forms will be signed by students and parents before attending extracurricular events. It is expected that fans of visiting schools will have signed an agreement form at their home school for events both home and away.



Spectator Agreement Form

(Guidelines and Expectations)

- The State Guidelines for Public Health Risk Level (Current-YELLOW) will be adhered to for extra-curricular activities where spectators may attend. They include but are not limited to the following:
 - Spectators will be expected to wear masks when entering/exiting the event
 - Spectators will be expected to wear masks when attending indoor and/or outdoor events during its entirety
 - Spectators will maintain physical social distancing whenever possible
 - Spectators will not attend events if exhibiting any symptoms (fever, cough, shortness of breath, sore throat, sudden change in taste or smell, muscle aches or pains, close contact with someone who has COVID19)
- All ticket purchases will be done in advance via electronic system or out of the main office. Same day ticketing will NOT be sold at the game/activity event.
- Wrist bands, electronic tickets, or paper tickets for Spectators are required for entrance no money will be taken at the door/gate.
- Be aware that cancellation of games may occur at any time due to concerns with COVID19.
- 25% of Stadium/Gym/Field capacities may attend and will be determined by schools based on their individual facilities. Schools will limit the number of spectators accordingly.
- Proper social distancing protocols will be adhered to for all spectators. Compliance of these
 expectations will be evaluated after every game/activity to determine future spectator
 admission.
