I understand that I may make arrangements to inspect a copy of the application and charter of this club. I am satisfied that, by either obtaining information from my student or by inspecting the club charter, or both, I have sufficient information about this club to make an informed decision regarding my student's participation in this club. I further understand that my consent may be withdrawn at any time by my notifying the school in writing of that withdrawal of consent.
