

UTAH JUVENILE COURT: EDUCATION COURT REPORT DIRECTIONS

The Utah Board of Juvenile Court judges determined the following information outlined in the form entitled "Education Court Report" as instrumental in providing judicial leadership for children and youth under the Court's jurisdiction. This information is to be provided in reports to the Court. While the use of this form is not mandatory, the information contained within the form is mandatory. The following provides clarification on each of the questions asked in the education court report:
